Reference is made to your application letter. Approval is hereby granted to your Company to Export the following products to the following destinations:-

This approval is subject to the following conditions:-

**A: FOREST PRODUCE:**

The Applicant has to submit the following for each consignment:-

- (i) A letter from the District and Regional Forest authorities' indicating that the said produce will be harvested in that District and Region.

- (ii) Original harvesting licence(s) and receipts to prove that the forest produce has been duly paid for.
- (iii) Proceedings of the negotiation meeting from which the produce were sold (for Mkurungu species only).

**B. EXPORT:**

1. Each consignment of timber/timber products to be exported must be graded and certified by an authorized timber grader prior and within two weeks before the shipment is made for each consignment.
2. An exporter is required to give a notice of at least one month for his timber to be inspected for grading, which shall be done within two weeks to shipment date.
3. The exporting company or individual is required to submit to the Director of Forestry and Beekeeping monthly and annually export returns indicating quantity exported ( $m^3$ ), destination and total value earned in Forex for each consignment exported.
4. Exporters of Timber and Timber products must adhere to "The Exports and Grading Rules of Timber" and exports regulations, (**copies can be obtained on request**).

**C. PROHIBITION:**

The export of round logs in whatever form and of all tree species and charcoal is prohibited.

**D. EXPIRY DATE OF THE PERMIT**

**This permit is valid from 25<sup>th</sup> July, 2018 up to 30<sup>th</sup> June, 2019.**

**E. WARNING**

- (i) Applicants who fail to prove that Government fees have been duly paid for, for the products they are intending to export, shall be required to pay the requisite Government fees before the produce is graded and allowed for export.
- (ii) Applicants have to pay a timber grading fee of Tshs. 153,400/= per consignment not exceeding  $20m^3$  before any consignment is graded/inspected and export certificate fee of Tshs. 150,500/= per consignment and fee for application form 5,000/=.

- (iii) Exporters who will contravene export regulations shall have their export permits withdrawn and may be blacklisted.
