A: FOREST PRODUCE:

SAMPLE

The Applicant has to submit the following for each consignment:-

- (i) Original harvesting license (s) and receipts to prove that the forest produce has been duly paid for.

B. IMPORT:

1. Each consignment of non timber products (*Tamarindus Indika Fruits*) to be imported must be inspected and certified by an authorized timber grader prior and within two weeks before the shipment is made for each consignment.
2. An importer is required to give a notice of at least one month for his non timber products to be inspected, which shall be done within two weeks to shipment date.
3. Importers of Timber and Non Timber products must adhere to "The Imports and Grading Rules of Timber" and exports regulations, (copies can be obtained on request).
4. A service charge of **Tshs. 115,000/=** per every **20Cbm/20tons** of every consignment shall be paid to the Chief Executive of the Tanzania Forest Service (TFS) before transportation.

C. EXPIRY DATE OF THE PERMIT

This permit is valid from 10th July, 2018 up to 30th June, 2019.

D. WARNING

- (i) Importers who will contravene import regulations shall have their import permits withdrawn and may be blacklisted.
